



**OLY Canada Legacy Grant 6th Edition  
Terms and Conditions  
December 2, 2024**

**1. APPLICATION**

**Application Deadline:** Friday, January 31, 2025, 11:59pm (23:59) Eastern Time.

To be considered for this year OLY Canada Legacy Grant (the “**OLY Canada Legacy Grant Fifth Edition**”), eligible individuals (“**Applicants**”) must go to the OLY Grant website at <https://sport.olympic.ca/oly/apply-today-for-the-oly-canada-legacy-grant/> (the “**Website**”) and complete and submit the application form (“**Application**”) in advance of the Application deadline. Applicants can submit a maximum of one (1) Application per category. Once submitted, Applicants cannot modify their Applications.

Submission of an Application signifies that you declare that you meet all eligibility criteria, that all information provided in your Application is true and accurate and that you have read and agree to these OLY Canada Legacy Grant Terms and Conditions (the “**Terms and Conditions**”).

**2. ELIGIBILITY CRITERIA**

**a. Applicants**

To be eligible to apply for the OLY Grant, Applicants must:

- currently reside in Canada;
- be Team Canada Legacy Olympians or active Olympians;
- have received their [OLY](#) nominal letters from [World Olympians Association](#);
- be in compliance with and not be under sanction under the [Olympic Charter](#), the [World Anti-Doping Code](#), Universal Code of Conduct to Prevent and Address Maltreatment in Sports and [COC Code of Ethics](#);
- meet all other eligibility criteria set out in these Terms and Conditions

**b. Projects**

To be eligible for the OLY Grant, Projects must:

- Be led and controlled primarily by an eligible Applicant (or a group of eligible Applicants);
  - Be organized as a not-for-profit organization or otherwise directly supporting a community-based initiative despite being constituted through different incorporation/organization form;
  - Be consistent with the values of the Olympic Charter;
  - Be implemented primarily during the calendar year 2025 and
- a. Meet all other eligibility criteria set out in these Terms and Conditions

### **3. GRANT CATEGORIES**

Sport has the power to transform lives, communities, and environments — far beyond. Team Canada Olympians show us their legacies can create positive change in the way we live, the way we treat each other, and the way we think about ourselves. The OLY Canada Legacy Grant is your chance to invest in that change. Here are the three Grant categories

1. Podium
2. Play
3. Planet

#### **PODIUM**

This category includes projects and programs that help support safe, inclusive and barrier-free sport by strengthening the sport system, supporting the athlete journey and providing research and training.

#### **PLAY**

This category includes projects and programs that help make sport more accessible for youth and communities, encourage youth to stay in sport and ensure diversity at all levels of sport.

#### **PLANET**

This category includes projects and programs that help make the planet a healthier place and support environmental sustainability.

### **4. GRANT DETAILS**

The OLY Legacy Grant Selection Committee (the “**Selection Committee**”) will review and evaluate Applications and will make a final recommendation to the Canadian Olympic Committee.

Successful Applicants will be offered the following:

- Grant: From \$1,000 to \$10,000 CDN, for use in connection with the Applicant’s Project in 2024

COC will also provide visibility to the successful Project(s) via COC-controlled platforms such as the OLY Canada website (OLY Life), Team Canada website (olympic.ca) and/or Team Canada social media channels (Instagram, Twitter, etc.).

If for any reason whatsoever, a successful Applicant is unable to accept the OLY Grant or does not agree to the terms of the OLY Grant Agreement, the OLY Grant will be forfeited without compensation or liability to the Canadian Olympic Committee, the Selection Committee and any partners, sponsors or agents.

## **5. GRANT AGREEMENT**

The OLY Grant is conditional on successful Applicant entering a OLY Canada Legacy Grant Recipient Agreement with the Canadian Olympic Committee. The OLY Canada Legacy Grant Recipient Agreement will outline rights and expectations which may include, without limitation, in exchange for receipt of the OLY Grant:

- Requirement to produce progress updates and key performance indicators regarding the Project;
- Project report/presentation upon completion of the Project/term;
- Compliance with the Universal Code of Conduct to Prevent and Address Maltreatment in Sport, the COC Code of Ethics and the COC Workplace Conduct Policy, as updated from time to time, available at: <http://olympic.ca/canadian-olympic-committee/governance/policies/> and other policies and procedures communicated by COC, in connection with the OLY Grant;
- Promotional requirements including contributing to social media posts promoting the OLY Grant;
- Rights to the Canadian Olympic Committee and its affiliated partners to use Applicant's name, image and Project details in connection with public messaging and promotion of the OLY Canada Legacy Grant

## **6. PERSONAL INFORMATION**

Names, addresses, telephone numbers and emails, Project details and other information provided by Applicant in connection with the OLY Grant is collected by the Canadian Olympic Committee and may be shared with the Selection Committee, sponsors, partners or agents for purposes related to the OLY Grant, which may include without limitation purposes of reviewing, evaluating and administering the Application. The Canadian Olympic Committee and/or the Selection Committee may also use this information to contact Applicants with questions or clarifications related to their Application. By submitting an Application and providing this information, you consent and agree to these uses.

## **7. GENERAL RULES**

To be proclaimed eligible, Applicants, Projects and Applications must meet all conditions and eligibility criteria set out in these Terms and Conditions. The decisions of the Canadian Olympic Committee and the Selection Committee with respect to all aspects of this OLY Grant are final and binding.

The OLY Grant is not transferable and includes only what is specifically mentioned in these Terms and Conditions. If the OLY Grant cannot be delivered as described in these Terms and Conditions, the Canadian Olympic Committee reserves the right to substitute one or more components with another, in its sole discretion.

The Canadian Olympic Committee reserves the right to amend these Terms and Conditions which may include changes to Project criteria, eligibility, categories, and timelines or to terminate the OLY Grant process at any time, without any liability to any Applicant. Any amendments to these Terms and Conditions will be posted on the Website. These Terms and Conditions shall govern in case of conflict with any other document.
